

Clinical Instructor of Dental Hygiene

The University of Cincinnati Blue Ash College invites applications for a Full Time Non-Tenure Track Clinical Instructor/Faculty position for the Dental Hygiene Department. UC Blue Ash College is the largest regional college in Ohio offering primarily associate degrees, with an enrollment of approximately 5,100 students. UC Blue Ash Dental Hygiene is a selective admissions program with approximately 40 students per class.

Clinical Instructor Faculty responsibilities include teaching and program development in the dental hygiene clinical and lab settings and patient care (performing dental hygiene duties). Other responsibilities associated with this position may include mentoring dental hygiene students; managing community service and service learning of students; conducting quality assurance; and managing remediation labs. The Clinical Instructor/Faculty member may also contribute to clinical research, the scholarly and service missions of the college, and other educational activities/expectations which may be described in the letter of appointment and in the unit reappointment and promotion criteria.

Minimum Qualifications: This position requires all of the following prior to the effective date of the appointment: a Bachelor's Degree in dental hygiene or health related field; an Ohio dental hygiene license or eligibility for an Ohio Dental Hygienist license as defined by the Ohio State Dental Board <http://dental.ohio.gov/Licensure/Dental-Hygienist#62388-dental-hygienist>; and an Ohio local anesthesia certification or eligibility for an Ohio local anesthesia certificate. Curriculum Vitae must document at least one academic year of teaching experience in a dental hygiene program. Teaching experience should include teaching in a clinical setting. Candidates must also have two years of clinical practice experience as a dental hygienist.

Applicants MUST upload the following documents to the application 1) a cover letter 2) CV/Resume, 3) unofficial transcripts, and 4) verification or eligibility to obtain an Ohio dental hygiene license and local anesthesia certificate.
