➤ Background

- The OSDB recently adopted rules which allow *properly-trained* registered dental hygienists to administer nitrous oxide sedation on dental patients. Furthermore, *properly-trained* dental assistants (of all classifications) may monitor patients receiving nitrous oxide. This course fulfills and exceeds the OSDB educational requirements for both groups. Additionally, this course is eligible for dentists & hygienists toward their 2012-13 biennial CE requirements.

➤ **Dates:** Saturday, October 19, 2013 (open to dentists, RDHs & all levels of dental assistants)

➤ **Venue:** Bass Lake Tavern & Inn, 460 South Street (State Route 44), Chardon, Ohio
(26 miles east of Cleveland)

➤ **Time:** 7:30 Registration, Course: 8:00AM – 5:30PM

➤ **Speaker:** Larry J. Sangrik, DDS

➤ Format

- The first portion of the course (at Bass Lake Inn) will consist of the lecture followed by a written exam for both hygienists and assistants. RDHs will then move to Dr. Sangrik's office (across the street) for a nitrous oxide demo, practice and an actual "rubber cup prophy" on a sedated patient (classmate). This will afford RDHs the opportunity to actually perform hygiene procedures while simultaneously administering nitrous oxide. Assistants may leave after passing the written exam or come to the office to observe nitrous oxide sedations.

➤ **Tuition** *(includes continental breakfast, luncheon, manual, study guide, lab participation, clinical supplies and exams)*

➤ Additional Information

- Class size is limited to 30 *total* participants; 20 RDHs & 10 assistants *(first paid, first enrolled)*
- Pregnant women should not participate in the clinical portion
- Basic Life Support for Healthcare Providers is required in addition to this course to administer or monitor nitrous oxide.
